Project Management

The contractor therefore does not participate in the profitability of the building works – its income reward is generated solely from its Fee.

Design & Build

Under this contractual engagement, strategies are developed based upon specific project requirements and schedules agreed upon. **DEP** extensive scheduling experience enables identification of materials and equipment with long fabrication and delivery time frames.
